MOZAMBIQUE VISA APPLICATION

Office hours (Monday to Friday): **09h00 to 13h00**

ALL NATIONALITIES travelling to Mozambique need to obtain an entry visa before arrival:

(Exceptions: Angola, Botswana, Malawi, Mauritius, South Africa, Swaziland, Tanzania, Zambia, Zimbabwe)

Applicants should comply with the following requirements and send to the Permanent Mission's official email:

- a) **Passport copy** with six months minimum validity. For foreigners residing in Switzerland: a copy of the residence permit.
- b) A **form** dully filled in, provided by the Consular Section. (It is obligatory to register the exact destination of the trip, date and signature on the 2nd page. The visa must be consumed within 60 days after its emission date).
- c) **Two passport photos**
- d) **A copy of the flight reservation**
- e) **Tourist visa:** A confirmation of the hotel reservation for the entire stay in Mozambique
- f) **Visit visa:** A writing of Terms of Responsibility is required from the person inviting, which needs to be certified by a local notary. If the host is Mozambican, a copy of the Mozambican passport and for foreigners who live in Mozambique, proof of residence permit or work permit and nationality passport must be presented.
- g) **Business visa:** A letter is required from the employer or institution of the applicant confirming the visit to Mozambique (in Switzerland) and another from the institution in Mozambique organizing the event, with a copy of Alvará (business license).
- h) **Diplomatic, Service passport and Laissez-Passer:** A Verbal Note from the employer of the applicant (in Switzerland) and another one from the institution in Mozambique organizing the event.
- i) **Humanitarian visa for non-diplomatic passport:** A Verbal Note, indicating the reason for the request and the expected period for the stay, criminal record certificate issued by the competent authority of the applicant's country of nationality or last residence for at least one year, translated into portuguese and legalized in Switzerland, Medical certificate, translated into portuguese and legalized in Switzerland.
- j) **Work with duration:** A Verbal Note, indicating the reason for the request and the expected period for the stay, Criminal record certificate issued by the competent authority of the applicant's country of nationality or last residence for at least one year, translated into portuguese and legalized in Switzerland, Medical certificate, translated into portuguese and legalized in Switzerland, Certificate of Work issued by the Ministry of Labor.
- k) **All payments must be done after documentation has been approved (Applicants will be notified when to make the payment).** The money must be deposited in the Permanent Mission of Mozambique's account: Account designation **MINEC-RECEITA CONSULAR**, Account Number **0215-218583.02V**, **IBAN: CH73 0021 5215 2185 8302 V (UBS - BIC/SWIFT - UBSWCHZH80A)**. **Kindly send the proof of payment after documentation has been approved.** After approval, only paid applications will be considered. **All transactions are irreversible/non-refundable.**
- l) For passports which will not be retrieved personally at the Mission: please include a stamped return envelope (C5 registered mail CHF 6.50 for 2 passports; C4 envelope: CHF 7.50 for 2 passports) – **For more information about the postal prices, kindly contact the post.**

PRICE LIST OF VISAS FOR ENTRY INTO MOZAMBIQUE, IN FORCE FROM 01.09.2019

PROCESS OF THE VISA REQUEST

1. For the initial request; all documents must be scanned and sent to our embassy's email address mission.mozambique@bluewin.ch;
2. We will forward the documents to the relevant authorities in Mozambique to request for authorization to issue the visa – this is the waiting period;
3. Once the authorization is received, we will notify you to send in your physical passport, two passport pictures and then we will ask you to proceed with the payment for the visa;
4. We will ask you to send us a copy of the proof of payment;
5. Lastly, when the visa is issued you will be informed to come to pick it up, on the other hand, those that have provided a self-addressed-stamped envelope at the beginning of their request will be sent back their passport by post.
